



CHILD SAFEGUARDING STATEMENT



The Football Association of Ireland (FAI) in accordance with the Handbook, Child Welfare and Safeguarding policy, other policies, procedures and our legislative requirements have agreed this Child Safeguarding Statement which is binding on all members. The FAI is a National Governing Body operating on a national scale. Providing sporting activities and opportunities for children and young people through participation in clubs, regional/provincial events and through our national teams. The FAI offers sporting activities to children and young people from the age of four years old. The FAI employs over 200 staff members and over 450,000 participants as defined in the FAI Handbook. The FAI is committed to safeguarding children and by working under the guidance of our Safeguarding Policies and procedures, our staff, both volunteers and employed working with our children and young people, throughout the. Association, seek to create a safe and fun environment for children and young people to participate in their sport.


Principles to Safeguard Children from Harm

As defined in the Children First Act, 2015, "harm" means, in relation to a child (a) assault, ill-treatment, or neglect of the child in a manner that seriously affects or is likely to seriously affect the child's health, development, or welfare, or (b) sexual abuse of the child, whether caused by a single act, omission or circumstance or a series or combination of acts, omissions, or circumstances, or otherwise. This statement recognises that in accordance with legislation and the requirements of our Handbook, Child Welfare and Child Safeguarding policy, other policies and procedures that the welfare and interests of children are paramount in all circumstances. The FAI is established on a number of core principles: - the needs of the Child, integrity and respect, environment, equality (protected regardless of race, ability, ethnicity or sexual orientation), fair play, welfare and safety in football. These underlying principles underpin our rules, policies and procedures to ensure that when Children participating in our activities, they do so, as far as is practicable, in a safe and enjoyable environment.

Risk Assessment

In preparing this statement the FAI have completed a Risk Assessment of the potential risk of harm to children when they are participating in any of our games and attending our activities. The risks were reviewed under the following headings; Club and Coaching Practices; Complaints & Discipline; Reporting Procedures; Use of Facilities; Recruitment; Communications; and General Risk of Harm. Each Football Association of Ireland affiliated Club/ League undertakes a separate written Club Risk Assessment. The Risk Assessment was undertaken on 14/07/2025. The table below lists the area of risk identified and the list of procedures and policies for managing these risks

The Football Association of Ireland's Child Safeguarding Statement has been developed in line with requirements under the Children First Act 2015, (the Children First: National Guidance for the Protection and Welfare of Children (2017), and Tusla's Child Safeguarding: A Guide for Policy, Procedure and Practice). Each Football Association of Ireland affiliated Club/League publishes their own Club Child Safeguarding Statement.

The FAI has the following procedures in place as part of our Safeguarding Policies:

- Procedures for the management of allegations of abuse or misconduct by staff or volunteers against a child availing of our activities;
- Procedures for the safe recruitment and selection of staff and volunteers to work with children in our activities;
- Procedures for provision of and access to child safeguarding training and information, including the identification of the occurrence of harm;
- Procedure for reporting of child protection or welfare concerns to Statutory Authorities;
- Procedures for maintaining a list of the persons in the relevant service who are mandated;
- Procedure for appointing a relevant person.

It has been provided to all staff, volunteers and any other persons involved with the service. It is readily accessible to parents and guardians on request. A copy of this Statement will be made available to Tusla and members of the public if requested.
